- [RCW 70.44.050](#) requires that the board's business be conducted by resolution or motion. This provision also requires that resolutions be adopted by most of the entire board of commissioners. AWPHD, with the help of [Municipal Research Services Center](#) (MRSC) has compiled a list of required resolutions. Please note this list may not be complete and we will work on updating it as other statutory mandates become known.

- All public hospital district commissioners must, within 90 days after taking the oath of office, receive training on the requirements of the Open Public Meetings Act
