We are led by a professional, full-time staff and an all-volunteer Board of Directors.





Required Training for Commissioners

All public hospital district commissioners must, within 90 days after taking the oath of office, receive training on the requirements of the Open Public Meetings Act (OPMA) and Public Records Act (PRA).

WA State Regulations for Commissioners

Washington State Legislature:

Governing Legal Authority over PHDs [Chapter 70.44 RCW](#)

RCW 70.44.050 requires that the board's business be conducted by resolution or motion. This provision also requires that resolutions be adopted by the majority of the board of commissioners. AWPHD, with the help of **Municipal Research Services Center (MRSC)** has compiled a list of required resolutions. Please note this list may not be complete and we will work on updating it as other statutory mandates become known.

Executive Session

A governing body subject to the OPMA is permitted to enter executive sessions only for the reasons specified in [RCW 42.30.110](#).

Some of the most common reasons for doing so are to discuss:

- The purchase or sale of land;
- Claims (or potential claims) against the agency for property or other damage;
- The qualifications of a potential appointee to fill an elected or appointed position; or
- Complaints or charges against a public official or employee.

- **Member Benefit Inter-Governmental Program**
